## **Approval of Minutes**

The meeting was called to order by Dave White at 6:30 pm. Dave asked for approval of the November meeting minutes and the minutes were approved unanimously.

**Financial Report:** Jim Christianson reported that the HOA began 2024 with a balance of \$37,650 which includes a \$20,000 CD. The CD matures on February 10 with interest. There was a brief discussion about the investment options for the \$20,000.

## 2024 Budget and Assessments

Dave presented an operating and reserve budget for 2024. The assessment letter and budget will be emailed to the homeowners on January 13 with a few notices going out by US mail.

Dave proposed a change to the assessment late fee. The first month will remain the same at \$25.00 but successive months will increase from \$7.50 to \$10.00. He noted that late fees generally are not charged when the payment is only a few days late. The Board approved the change, the budget and the plan for distributing assessment notices.

#### Repairs Other Than Items Already in Budget

Dave listed several new repair and maintenance items that had arisen since the last meeting:

- Leaking sprinkler valve at Alta Mesa
- Replacement batteries and solar panel for Harris Parkway irrigation.
- Repair sprinkler head on Harris Parkway
- Repair leaking drip hose on Harris Monument bed
- Troubleshoot and repair sprinkler zone 4 on Harris Parkway
- Complete exit gate post replacement

# **Upcoming Budgeted Items**

- Install weed barrier in Harris Monument bed \$850
- Mulch and add grasses to Center Island \$1,750
- Install cap columns \$5,000

## **ACC Report:** Paul Roberts reported the following

## General

All HOA owned perimeter fences are intact. Bruce Aldridge informed Paul that the developer of the assisted living area adjacent to his and Diane Alexander's properties (7100 and 7101 Axis Ct) will be building a masonry retaining wall some 15 feet outside the HOA property line along with a masonry fence to replace the present wooden fence.

# Modification Requests

One modification request was worked this period. Thornton at 7163 Axis Ct for a temporary greenhouse to protect pool equipment from coming cold temperatures.

## • South brick fence

We have begun planning for installation of concrete block caps on the small pillars.
